ORDER



Consequent upon constitution of 'West Bengal Scheduled Castes, Scheduled Tribes and Other Backward Classes Development & Finance Corporation' by merging erstwhile two corporations, viz. 'WB SCs & STs Dev & Fin Corporation' and 'WB Backward Classes Dev & Fin Corporation' under Act XXX of 2017, here-in-after be referred as the said Act, notified in the official Gazette vide No. 1092-L dated 13 September 2017 of the Law Department read with Notification No. 3737-BCW-7P-16/17 dated 6th November 2017 of the Backward Classes Welfare Department, Government of West Bengal the earlier Acts were repealed with effect from 15 November, 2017.

Now, In terms of Sec 33 (3) (c) of the said Act read with Sec 10 and concurrence of the State Government in the Backward Classes Welfare Department dated 28 November 2017, it is hereby declared that all officers and other employees of the erstwhile two corporations shall continue in the service of the new Corporation i.e. "WB SCs, STs & OBCs Development & Finance Corporation" and shall hold their office or service by the same tenure, at the same remuneration, upon the same terms and conditions with the same obligation and with the same rights and privileges, not inconsistent with the extant Govt. Rules and orders, as held by them in the Corporations under the repealed Acts. Officers or other employees of the erstwhile Corporations who opt for not continuing in the service of the new Corporation shall have to submit their option to that effect before expiry of a period of six months from the date of the new Act coming into effect, i.e. 15 November 2017.

This provision shall be deemed to have come into effect from 15 November 2017 and shall continue until further order of the State Government.
