Consequent upon enactment of “West Bengal Scheduled Castes, Scheduled Tribes and Other Backward Classes Development & Finance Corporation” Act 2017 (West Bengal Act XXX of 2017) (henceforth said Act) which was duly notified vide 1092-L dated 13th September 2017 of Law Department, Government of West Bengal read with no-3737-BCW/7P-16/17 dated 6th November 2017 of the Backward Classes Welfare Department, Government of West Bengal, the “West Bengal Scheduled Castes, Scheduled Tribes and Other Backward Classes Development & Finance Corporation” has come into existence on and from 15th November 2017.

Now, in terms of Section 9(1) of the said Act, the Governor is pleased to approve of the proposal of the said Corporation to set up its ‘Head Office’ at the premises of “CF -217/A/1, Sector-I, Salt Lake, Kolkata -700064” and this address shall henceforth be treated as the registered address of the said Corporation.

In terms of Section 9(1) of the said Act the Governor is further pleased to approve of the proposal of the Corporation to utilize the existing facilities of the erstwhile “WB SC & ST Development & Finance Corporation” to set up one District Branch Office at District HQs of each of the 23 Districts, with exception of Darjeeling District, which shall have two District Branch offices, one at Siliguri for areas under Siliguri Mahakuma Parishad and the other at Darjeeling for areas under GTA on ‘as is where is’ basis until further order.
