Shri P. Manna, Managing Director, WBSCSTOBCDFC - In the Chair

- 1. As per the Bidding Schedule, pre-bid meeting was held with the representatives of prospective bidders (list attached) on Tuesday, 22nd October, 2024 at 4 P.M.
- 2. Two prospective bidders, Career Point Limited and Resonance Eduventures Limited, requested for the following relaxations:
 - (i) Obtaining Satisfactory Completion Certificates from past Government assignments may be difficult. In such cases, bidders may be allowed to submit proof of receipt of payment from the Government authorities, to establish satisfactory completion of the assignment.
 - (ii) If the centres have been set up by the franchisees of the bidder, then the bidders may be allowed to submit the GST registration certificates of the franchisees towards proof of setting up of the centres, instead of the trade licenses of the bidders.
 - (iii) If the centres have been set up by Government entities, the bidders should not be allowed to use the same as their credentials.
 - (iv) Relaxation of marking pertaining to credentials related to centres operated in West Bengal and students trained in West Bengal, to encourage greater participation from entities presently not operating in West Bengal at a large scale.'



3. The prospective bidders, National Computer Saksharta Mission & Target Classes, suggested the following changes:

(i) Experience in undertaking prior Government assignment may be made mandatory for qualification purpose & that should be given 30% weightage

during technical marking.

(ii) The liquidated damages to be payable by the Selected Bidder for failure to get students obtain rank enabling admission in Govt. colleges, has been specified to be for failing to secure for a minimum of 30% of students in the GCC and for a minimum of 50% of students in the e-NIT of the Bidding Documents. Since the category of students involves General and Minority category students in the training programme, such minimum requirement was requested to be reduced to 6% and the maximum percentage of rank holders, required to obtain the full final instalment of 25% of the Course Fee was proposed to be brought down from 50% to 20%. Such suggestion was also seconded by Career Point Limited and Resonance Eduventures Limited.

4. The Tender Committee deliberated on the suggestions and upon deliberating on the suggestions, decided as follows:

- (a) The bidders may submit proof of receipt of full payment of the Work Order value also instead of Satisfactory Completion Certificate for past Government assignments, by submitting TDS certificates and/or bank statements. However, such credential will only be considered, when the payments proof matches the Work Order value.
- (b) If the training assignment is continuing, the bidder should submit a partial completion certificate obtained from the Government entity which had entrusted the assignment stating that the work undertaken so far has been satisfactory. Proof of payment of partial value of the training contract shall not be accepted as a valid document.
- (c) The present Bidding Documents lays down a complete prohibition on the Selected Bidder in sub-letting/ sub-contracting/ operating through franchisees of the training contract. Therefore, credentials of any franchisees of the bidders would not be taken into consideration and no change on this ground, will be made in the Bidding Documents.
- (d) While prior Government assignment experience is not a mandatory eligibility criterion, marks have been provided for prior Government assignment experience being credential for similar kind of works. Likewise, if any Agency set up centres under any Govt. project, those centres may well be used for the purpose of credentials. Therefore, no changes pertaining to Government assignment experience and use of centres set up by Agency



- under any Govt programme for training will therefore be carried out in the Bidding Documents.
- (e) To create a more level playing field for agencies who may have significant all-India presence but less experience and presence in West Bengal, the marking scheme was decided to be modified as follows:
